

April 19th Marks the 13th Anniversary of Waco and 10th of Oklahoma City Bombing and No Justice, Yet!

CS is actually a fine powder and the UN for military usage has banned it. It is designed for OUTSIDE usage and is KNOWN to be fatal in confined areas.

These folks planned to murder the children as well as adults. By their own statements they PLANNED to use CS gas for 48 hours to try to get the Davidians to surrender. They however used all the CS in EIGHT HOURS! In concentrations inside a building CS can be deadly in less than an hour of continuous usage. This information would have been available to Butcher Janet Reno before they used it. Butch Nero has been suffering from Parkinson's disease since Waco. Her tremors have been evident since the Waco hearings before Congress; you can't say God isn't already starting to deal with her. I wish her a LONG and eventful life.

Until Americans say NO MORE, and pull together, we will have no hope of keeping an event like Waco from happening again. In the latter film *WACO: A New Revelation*, there is photographic evidence that DELTA FORCE used explosives to blow a hole through “the bunker” a former safe, where women and children had gathered to try to escape the CS gas. A new side-by-side stainless steel refrigerator in the same enclosure was FLATTENED. Assuring the death of all those inside.

Delta Force entered the compound BEFORE the inferno. David Koresh and his major deacons were found with a single gunshot wound between their eyes that was NOT self-inflicted. This is against Koresh’s orders. He instructed his members on more than one occasion that, “although I do not advocate suicide, if for some reason you have to shoot yourself place the barrel of the gun in your mouth and pull the trigger. If you place it to your head you may flinch and miss making yourself incapable of finishing the job and end up a vegetable.” Considering these instruction, it is more than odd that not only Koresh’s top men but Koresh also had a single gunshot wound to their forehead with no trace of powder burns, meaning they were shot from at least 3 feet away.

The overwhelming evidence is that; Delta Force made entrance into the ”compound” shot these people started the fire, withdrew maintaining a field fire as they left the building keeping those inside the building there to die in the holocaust their teams created.

This American holocaust was created as a WARNING to others that might dare stand against tyranny. A warning of what might just happen to other patriot or religious groups if they decided to stand against the powers that be.



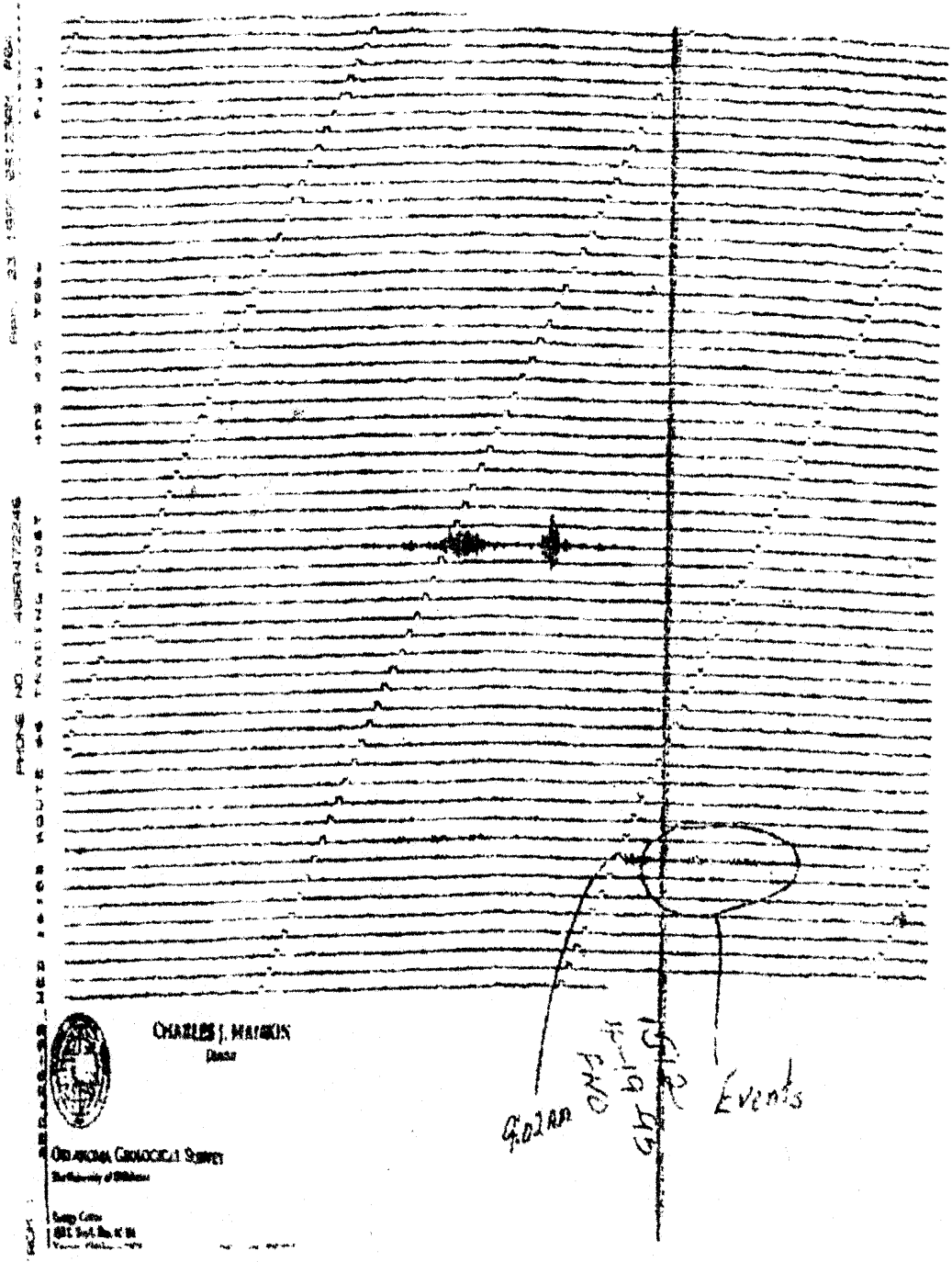
Vernon Howell as David Koresh however declared he was “the Lamb of God” quite possible fulfilling:

RECORD OF BOMBS DETONATED AT FEDERAL COURT HOUSE IN OKLAHOMA CITY

The seismograph picked up two events shortly after 9:00 a.m. that seem to be related to the bombing of the Federal Court House in Oklahoma. The first surface wave arrived at 9:02 and ~~12~~¹³ seconds and the second arrived at 9:02 and ~~24~~ seconds. Given the travel time for the surface waves, that would make the time of the first blast at 9:02 and 4 seconds and the second blast 10 seconds later. If the report that two bombs were detonated at about 9:00 a.m. is correct, then these are the likely signals from those blasts.

These documented TWO separate blasts 10 seconds apart. There were barometric switches found in the building indicating that the overpressure of the first blast (truck bomb) was used to set off secondary charges within the building. The news media were moved back 5 times because of other explosives found in the building. There were three explosive devices found. The first two were disarmed by the bomb squad and reported to have been BIGGER than the first bomb that went off. The bomb squad could NOT

disarm the third device. EOD, Explosive Ordinance Disposal of the military, had to be called in because it was a military device reported to be hooked to drums of fulminated mercury. If these bombs had gone off there would have been little left standing of the Murrah Building.

In the trial of both Terry Nichols & Lee Harvey McVeigh, I mean, Timothy McVeigh the judge repeatedly refused to allow any evidence that incriminated anyone but these two men in the bombing.

Enter, Carey James Gagen giving sworn testimony before a second grand jury convened by the people of Oklahoma because the persecutors, I mean prosecutors, refused to.

In his sworn deposition and testimony Mr. Gagen brought forth paperwork from the Justice Department giving him 15 months immunity from prosecution. He was in the middle of the Arab group that placed explosives inside the building. Al Hussani Hussein was involved. Gagen warned his handlers two weeks before the bombing of what was about to happen. None of them did anything! They refused to bring him in to reveal the plot. They refused to listen. BOOM! There has still been no credible explanation why Federal Judges were warned not to come in on April 19th due to possible terrorist attack. Why ATF agents were warned by their beepers the night before not to come in. Why there were NO FBI agents were at work in the building either. Even the Southern Poverty Law Center didn't show that day. All had warnings EXCEPT the children in the day care center.

In Gagen's testimony photos and names of the Arabs terrorist were given. Al Hussani Hussein was involved as well as being implicated in the first World Trade Center bombing and 9-11 also. Many of these terrorists were part of a group of around 10,000 Arabs brought in by the first Bush administration after the gulf war. Many were of Saddam Hussein's royal guard. All just turned loose in America for what purpose only the CIA and George H. W. Bush knew.

James Forrestal, America's first Secretary of Defense who so brilliantly put it, "if these things happened by accident they would occasionally make a mistake in OUR favor". Forrestal spoke of blunders by the war department and the State Department the latter which had become infiltrated with communists. He spoke of decisions handed by the powers that be in Washington, today is no different. Yet most today are to blind to see, or too apathetic to care, it saddens me greatly to think how far we have fallen.

We were once a great nation with people who cared about what happened within their country. Cared so much so they were willing to put their very lives on the line in order to straiten things out.

Today we swallow the propaganda pumped out by the administration through the controlled media as if it were a gospel handed from Mount Sinai itself, no matter what the facts say.

We have as a nation turned our backs on God, allowing the Common Law, based on God's law, to be taken from our courts without so much as a whimper.
