#### **ILKLEY MOOR SHOOT POSTPONED**

Bite Back: 18th July - 4th Aug

**ENCLOSURES DESTROYED** 

Organisers of the cruel grouse shoot on Ilkley Moor, The Bingley Moor Partnership, has said there will be no shooting for at least two years, because of a shortage of grouse to kill. The news was announced after three of the six sabotage actions (so far) reported by the Animal Liberation Front and Grouse Liberation Front on the moors of Ilkley, prior to the shooting season which started this month. See FS! #3 for the first ALF action.

#### **GLF SABOTAGE MOORS**

Up in the White Crag plantation off Ilkley moor. A large grouse pen was identified and trashed, the water pipes and distributors were left split and smashed. The wire fencing from the entire enclosure was brought down. The electric fencing was cut and the system destroyed. Two set fen traps were discovered and placed permanently out of commission.

Two smaller pens were found nearby and the netting roof and wire surrounds were left in tatters. Feeders in the area were also tampered with.

Grouse Liberation Front

Up around High Moor, Ilkley activists located two small grouse pens which were put out of use. The contents of the pens were destroyed. A fen trap was found nearby and also destroyed. Along the moor a line of stone grouse butts were toppled, and wooden butts smashed. Into the High Moor woodland, and a large pheasant pen was found, the walls were brought down and two traps tampered with, water pipes were cut and other items left broken. Feeders were also attended to.

This action is dedicated to the Austrian prisoners.

#### **BARDON HIT AGAIN**

Inspired by an action earlier this year we decided to hit Bardons quarry in Burto-on-trent. Bardon are part of a group responsible for the destrution of mountains at the Glensanda Quarry in Scotland. This is one of the largest quarrys in Europe and exports stone for road construction.

This can not be allowed. As the security watched TV we slashed tyres, stripped paint jobs, Glued locks and trashed convayor belts. All the earth movers were hit and many of the cement and agrregate trucks. This action cost us very little but should cost bardon thousands.

We all know lobbying gets us little, we all know that once a mountain is gone it is gone forever, we all know time for the earth is running out. We all have fear that stops us acting but we must act.

#### **ANTI-SPRAWL ARSON**

ELF claims arson on urban sprawling project in Älmhult, Sweden the 25/7. An estimated 2 millionSEK villa was burnt to the ground, in response to the increasing urban sprawling as well in Älmhult as in Sweden and the civilisation all over.

#### 32 SUVs DISABLED

Up to 32 SUV owners awoke this morning to discover that their destructive vehicles had been disabled.

Using the 'mung bean trick', whereby a mung bean is inserted into the valve of a tyre before the cap is screwed back on, tyres were let down in Marston, Headington, and the highly affluent area of Summertown. Messages were left under windscreen wipers warning the owners not to attempt to drive their 4x4s, and explaining why it was felt that direct action had to be taken to resist their assault on this planet.

They were informed that more than a quarter of the UK's CO2 generation is attributable to the transport sector, and that many Sports Utility Vehicles emit up to 300% more greenhouse gases than the average car.

They were also told that driving a car is not a 'right', and that driving an SUV is an unacceptably selfish act in the face of what may become unstoppable climate change. This is a simple action that anyone can do, anytime or place.

We guess the costs for this venture are increasing. The prestige of presiding over Rombalds moor is diminishina. We ask Bradford City Council and the Bingley Moor Partnership to back out of plans to profit from blasting llkley grouse apart, and in turn commit to leavina Ilklev moor as a place where arouse and other animals can live without the threat of shotauns, larsen traps or fen traps and any of the other hideous methods used by gamekeepers. This action is dedicated to Anne Hawksworth, Bradford councillor and cheerleader for the shoot.

#### **PHEASANTS FREED - ALF**

In Woodland situated to the north east of Denton moor, a large number of shooting sites were found, and inevitably two pheasant pens. In each of the pens a hole was cut in the fencing and feed placed around the gap. All the water dispensers were removed from the pens and left with holes, all the feeders were also removed. Over 125 kilos of feed in total was placed around the pens and into the surrounding woodland. Water from the large containers was poured into the feed stores, with over 350 kilos of pheasant feed affected. The locks to the pens were also filled with glue.



Cruttenden (employed by HLS and a whole host of others) actually advising various corporations about activists seeking to seize assets and curb all protest. He has given many statements which exclude vital information for example in 2000 he gave evidence that the A1 was blocked by anti vivisection activists on tripods and that a car was scratched he omitted the fact that a servina police officer nearly killed a protester by pulling a tripod over (causing severe facial injuries, blood loss and fractures to the left lea) and even said that he was not aware that anyone was injured when he was questioned by Cambridgeshire professional Standards. He had sat in the same room as that activist at the Girton planning enquiry when the same activist gave evidence about her injuries and police violence a few years prior to him writing this statement.

In all NETCU are at the front-line in makina ALL activists into lona term prisoners with all assets taken by the state or corporations with whom they work closely. They must be challenged and do not think for a second that if you only do "legal" things they are not interested, if you are effective they want you and badly. Yes we know that Steve Pearl and some of the FIT teams may appear very endearing but we stress that their job is to destroy any criticism of vivisection for now and it would appear climate change in the near future. Eternal vigilance, play nicely with the police, be share a joke, swap badges (one of us got a very nice Sussex police sticker

by the way) and never be violent towards them (unless you really do have to defend yourself/others against serious injury/death) but also never forget that they are our enemy and want information about every one of us right down to the last babe in arms to be fed back to NETCU who will then use that information in any way possible to fuck up people's lives work, family, friends every single aspect.

NETCU have also lied they said that Eon was not disrupted during the protest and so why oh why have Kent police charged 4 people with aggravated trespass accusing them of causing the river flow in to the plant to be stopped by Eon because of their position on the ledge above the water inlet? Maybe the more technically minded can help us here but how does a power station run without a cooling system? Are Kent police lying or misled by Eon? We suppose time will tell.

As for the local people, many had to endure being harassed, assaulted and bullied by police when they walked their dogs, went jogaing or to the shops. Many of us are used to being pushed around by police and we expect it as activists although we tend to know our rights, stick together and fight back through the courts. What is truly frightening is how everyone in a certain area had to justify their normal activities to the state it was although martial law had been declared and an army of occupation had marched in. As was the case at the animal rights

# MORE TROUBLE FOR BARCLAYS BANK ACTIONS DEDICATED TO DAN AMOS

Over the last few days, NETCU-ALF Division have been out tactically coordinating some extremist activity. 5 Barclay's cash points in Surrey / Hampshire have been rendered useless with a liberal application of super glue.

We would like to make it clear that this action was NOT taken as a result of the handful of LSR (Huntingdon) shares held by Barclays. Keep them, sell them we don't really care. What we are concerned about is your massive investment in the NYSE Euronext. You have the power to pressure the NYSE into dumping HLS once and for all.

The fact that Huntingdon's largest shareholder owns just a quarter of a million shares is laughable. Now that they have been forced into this position of pathetic investments, we are no longer interested in who holds LSR shares. What we want is for Huntingdon to have NO shares. Therefore our demand is simple. Get HLS off of the NYSE Euronext. There will be no compromise. Dumping your LSR shares will not end this, only rectifying the cowards mistake made in December 2006 by the NYSE will end this.

Until such a time as LSR shares are traded by the NYSE, all shareholders, specialists, clearing agents, interests, as well as their subsidiaries, investments are deemed eligible targets.

Yes Goldman Sach's, that means your 25% stake in Pret a Manger makes them a target. Barclay's machines and banks will continue to be sabotaged. AXA branches are also on the list. Until the NYSE makes the right decision, the screws will continue to be tightened, until one of you screams louder than HLS did in December '06. If you have an Achilles heel, we will find it.

We were going to dedicate this action to our esteemed leader, Steve Pearl, but in light of recent circumstances, this one goes out to the recently interned peaceful protestor Daniel Amos. You should have joined the ALF lad!

Its time to stop throwing abuse, and start throwing rocks. Get on the streets and hammer Barclays, Pret a Manger, AXA and anyone else involved in the NYSE.

#### LIBERATIONS FOR AUSTRIAN PRISONERS

2,000 MINK FREED (GERMANY)

We could smell the horrible stench long before we reached the fur farm in Schlesen near Kiel on the night of July 22, 2008! The animals were locked-up four to a cage! The whole farm was in terrible condition! There were many we could not help this night! But we released at least 2000 mink! We gave them a chance to escape. A chance is better because in a few months they will be killed by the farmer. These animals deserve freedom! This action is dedicated to the imprisoned Austrian animal activists

#### **FOUR MINK FREED (SPAIN)**



In July 2008, Four mink were carefully removed from cages from a fur farm in northern Spain, later releasing them into a natural environment many miles away. This was the second open rescue by the Open Rescue Team of Igualdad Animal (Animal Equalty), in August 2007, six baby pigs were rescued from an intensive farm.

Expert from report (translation): Although legally non-human animals, including mink, are

considered property and therefore to remove them from cages is considered 'theft,' a criminal act, at Igualdad Animal we believe that no individual is the property of another and the moment has arrived to liberate our slaves. Just as in the past when some humans were considered property of others and this was an unjust situation, currently we are still involved with slavery. Animals are not property and to liberate them is not robbery but a legitimate act of justice.

With these open rescues we not only intend to rescue a few animals that were aoing to suffer and die. but we want to provoke a social debate that causes us to rethink the exploitation to which we subject the animals with whom we share the planet, and to bring about a change of mentality and habits of consumption in each one of us, because ultimately we are the ones who-- with our daily decisions of how we dress ourselves. feed ourselves, or entertain ourselves-- can put an end to the daily suffering and death of animals.

We also want to remember all of the victims who still remain in cages, to show our support for all those who rescue caged animals, and finally to dedicate this action to the Austrian prisoners Martin, Christian, Christof, Elmar, Felix, Jan, Jürgen, Kevin, Leo and Sabine, who at this moment are victims of an unjust judicial system.

not deemed to be anti social. In addition there is no evidence to support any residents suffering from harassment alarm or distress on that date and so section 42 does not apply. The arrest is therefore unlawful and any actions taken thereafter are also deemed to be unlawful.

#### **Recommendation**

All aspects of the complaint are substantiated.

It is clear from the investigation that officers have been provided with a briefing note, which interprets the use of legislation in an ambiguous way. This has led to officers becoming confused when faced with protesters about how to enforce their powers".

Despite asking the police in West Mercia professional standards, on bended knee in fact, for the "briefing note" we were politely refused.

Briefing note, handbook, whatever NETCU have encouraged their fellow officers to use powers they do not have. For those who still do not understand this handbook in our hands now enables our lawyers to go through it with a fine tooth comb to find any ambiguities which can then be used against the police in both criminal and civil courts. The Chief Constable of Kent police may find his financial problems are just beginning when the complaints

start and claims for financial compensation from hundreds of activists pour in. Julie Spence Chief Constable of Cambridgeshire Police and Steve Pearl's boss may also find that she is requesting more funds. NETCU may well prove to be more trouble than they are worth, they may also rewrite the document, change contact details and redistribute which will disrupt their activities and cost them some more money. There is also the embarrassment factor to account for.

We urge any activist (no matter what demonstration/action they were arrested for) facing court to make sure that their lawyer has a copy of this booklet as the information therein may have been used as a basis for arrest, that information might be incorrect. Activists who have had cases dropped may find that an arrest made using the handbook was unlawful, they might find it helpful in suing the police.

Complaints can be made about NETCU if made against Superintendent Pearl who leads the unit. Bear in mind NETCU have sought to imprison every last animal rights activist who does more than write a polite letter to the paper/MP. They specifically want to disrupt every demonstration, stall, the handing out of leaflets and tend to gloat every time they succeed. Animal rights people have also been to the Royal Courts of Justice to find Steve Pearl (head of NETCU) sitting behind Timothy Lawson-

#### The Hoo Peninsular becomes a fully functioning police state but police fail miserably!

Where can we start. Having just come back from climate camp tired but VERY happy and so impressed by our fellow activists whose dignity, good humour and super human restraint meant that NETCU and those who they "advise" (ie the 27 different police forces present, the home office and probably Eon too) failed to invade the camp and even failed to stop Eon's fences being breached! Please log on to Indymedia with their excellent reports of the week.

First of all a riot cop left behind the NETCU handbook which as regular visitors to this site will know has been sought for many years now. Some have said that because it is just "legal advice" that this is hardly a revelation, we respond by saying that we now have NETCUs fax number, phone number and email address. Beforehand we only had

their PO box in Huntingdon Cambridgeshire. Now we have a Huntingdon telephone code we can very stronaly assume that Superintendent Pearl and his minions are holed up in Hinchingbrooke Park at Cambridgeshire police HQ which might be a good place to demonstrate against unprovoked police violence against activists. The threat to charge children and batter them with batons issued from a low flying helicopter on the orange march springs to mind as does riot police charging lines of us whilst we simply held our ground not retaliating at all to the pepper gas or batons.

The handbook has also been thought to be very important since it featured heavily in arrests at Sequani in 2006. Four arrests were found to be unlawful by West Mercia professional standards, £25,000 in compensation was awarded to activists and we quote their findings after their investigation:

"The force legal department advised that the elements of section 42 and 50 are not made out, as there is no antisocial behaviour displayed by the protesters when the police arrived. Ms S's actions in requesting officer details and taking pictures on her mobile phone of the officers are

individuality and the desire to breathe fresh air, see the sunlight, run in the grass, dig a hole in the ground, live their life.

For those who see this farm from the outside it is a shed like many others, for those working in it a job like many others.

For the animals concentrated in this hell it is neverending torture. Closed and crowded one on the other in small cages, where they cannot even stand on their feet, stretch the leas or move like every living body needs to do, the rabbits lay here without knowing the reason of such a wasted life: killed by boredom, from physical pain, stress and depression, later on by ignorance and cruelty of researchers in labs. These people claim their work as absolutely important for our life, aiving as granted that the thousands of drugs and cosmetics on the market after being tested on animals are so necessary for our well being.

Even if this was true, there would be no reason to raise and make suffer other inhabitants of this world to fulfill human needs.

Every animal (human included) owns the vital instinct to hide when it feels in danger, to have a protected area, and for these rabbits not being able to dig holes makes them crazy.

We cannot stop thinking about them: from the first time we entered, during a reconnaissance, their eyes and the conditions have been in our minds: dozens of small babies fallen from the cages into the waste pits, dying in faeces; other crushed by the weight of their brothers or with horrible malformations.

After emptying completely some rows of cages we smashed them so that the farmer will have problems putting back those he will catch. Thirty lucky rabbits came with us and are now in a free and protected environment. Some pictures and a video can help you have an idea of Fasolato's farm.

Barclays Investors in animal cruelty have had a cash machine disabled by glue. This is just a warning. This wont stop even if they sell their shares in HLS. They need to sell their shares in the NYSE...

HLS - NYSE = NO Shareholders (NO HLS)
