Speaker Biographies

Chair – Ian Hutcheson

As Director of Security, for BAA Ian is responsible for security strategy, policy and assurance for all BAA businesses.

He has direct working relationships with all European and UK Regulatory and Law Enforcement agencies concerned with Aviation Security.

Prior to joining BAA in November 1997, Ian had a distinguished career with the London Metropolitan Police. During his career he was directly involved with a number of terrorist incidents in Central London and at Heathrow Airport. These included the siege of the Iranian embassy in 1980, the Libyan Peoples Bureau Siege in 1984 and in 1987 when he commanded the armed response teams at Heathrow the attempt to sabotage an El Al aircraft. (Hindawi incident).

Following the 9 - 11 attacks Ian presented Testimony to the US House of Representatives Transportation Sub-Committee on Aviation. He is also a member of the National Aviation Security, Committee, Operational Response Sub-Committee, and represents Europe's airports at the European Commission.

Edgar Beugels

Edgar Beugels is a lawyer by education. He worked for 15 years for the Immigration Service (IND) of the Netherlands before joining Frontex (the European Union's External Border Agency), right from its foundation in 2005. Initially, he worked there as the acting security officer, but since 2007 he is active for the Research and Development Unit. At present Edgar is the Head of that Unit.

His unit undertakes research/studies in the field of border security for the benefit of the member states of the European Union and the European Commission and participates in short, mid and long term border security related projects being executed at the EU level. The development of common (technical) requirements and standards at the EU level for equipment to be used for border checks and border surveillance is one of the focal points of the unit.

During the past years Edgar actively participated in the development of the border control/security policy at both a national and international level (EU and beyond). He was deeply involved (participation in EU Council Working Groups) in the development of the Schengen acquis (creating the borderless area between the member states of the EU) as well as its implementation (Schengen Evaluation). Before joining Frontex he was also responsible for the negotiations between the Netherlands and the USA (DHS) on a transatlantic automated border passage/registered traveler program. As a policy advisor he facilitated the introduction of innovative techniques in the field of border control (automated border control-biometrics based).

He was participant in numerous missions to all Schengen member states as well as a participant in numerous border control related missions to all continents of the world.

Tony McCarthy

Tony has 20 years police service in the Metropolitan Police and Sussex Police. He is currently seconded to the ACPO (Terrorism and Allied Matters) Office of the National Co-ordinator PROTECT, since 2006.

He is senior liaison to the UK Border Agency and SOCA for border-related matters, and also leads on matters concerning FRONTEX and the Common Travel Area. He leads on a project that considers Community Impact from the use of counter-terrorism legislation at ports, and has recently established a national accountability framework concerning the police use of Schedule 7 Terrorism Act 2000 powers.

Tony represented UK Police during the 2007 Cabinet Office Border Review that resulted in the establishment of the UK Border Agency and is currently engaged in work to consider options for the future of border policing. He has worked overseas in Kosovo (United Nations Mission 2000/1) and Bosnia-Herzegovina (EU Police Mission 2004/6) where he was an advisor to the Directorate of the State Border Service.

Tony is currently studying a master's degree course in Countering Organised Crime and Terrorism at University College London.

Paul Kiteley

Paul has been an officer in the Metropolitan Police Service for 26 years. His first fifteen years were spent in local policing predominantly as a CID officer. He then moved on to more specialised areas within the Specialist Crime Directorate where he worked on high profile confidential and sensitive enquiries. In 2006 he joined Special Branch at Heathrow Airport, running the newly formed Cargo Unit, which now sits within the Counter Terrorism Command. Since June 2008 he has also been Chair, National Joint Freight Intelligence Group (Air) reporting to the National Co-ordinator PROTECT, ACPO (TAM).

Bob Chatterton

Bob joined Essex Police in April 1982, and has specialised in the fields of Intelligence, Serious Organised Crime, Public Protection, Training (Crime and Detective development programmes) and Counter Terrorism. As the PREVENT lead for Essex for the last two years he developed a Community Engagement programme to reach minority communities through Neighbourhood Policing and Crime and Disorder Reduction Partnerships. Bob became Head of Special Branch in August 2007 where he was responsible for Counter Terrorism and Domestic Extremism issues in Essex.

In February 2009 Bob was seconded to the Identity and Passport Service (Strategy to support the implementation of the National Identity Card programme within the UK).

Vaughn High

Vaughn has been a serving Essex Police officer since 1986, and had previously been qualified as a Marine engineer and later Commercial Inspection Diver working in the offshore oil industry. By 1989 he moved towards specialising in crime as part of a dedicated tactical team, then became a CID officer. Following promotion in 1997 he took responsibility for a crime team in the Harlow Division before returning to CID as a Detective Sergeant in the Braintree Division.

Seven years later he joined Essex Special Branch Ports office at Stansted Airport gaining Surveillance and Source Handling qualifications. Whilst at the airport Vaughn led the intelligence cell which determined the principle business of the airport resources, before moving to the Small Ports position specialising in General Aviation and Maritime matters.

Duncan Hine

Duncan joined IPS in mid 2007 prior to this he was the managing director of the security division of QinetiQ PLC, joining from Generics AG where he was a key part of the team that listed the company on the London Exchange. Prior to this he was the Group CTO of The Post Office in the United Kingdom. Duncan was the senior non executive director of Northgate PLC for seven years, and combines his role at IPS with a number of other activities including directorships in the health, and security industries, leading a European blue chip innovation network, and a visiting professorship at York University.

Duncan has overall accountability for security and counter fraud for IPS and manages the co-ordination of risk and integrity for the passport service and the National Identity Scheme. He also has external interests the security industry, leads a European blue chip innovation network and is a visiting professor at York University.

Lorraine Morrison

DCI Lorraine Morrison joined the Metropolitan Police in 1981 worked in Inner London Boroughs of Harlesden and Peckham in a variety of roles. Transferred to Sussex Police in 1997, worked in uniform then in the Specialist Investigations Branch as a Senior Investigating Officer moving to Special Branch , now renamed the Counter Terrorist Intelligence Unit. With Initial responsibility for the South East Counter Terrorist Unit and Sussex Special Branch in October 2008 took on role of Head of Ports Policing which covers Gatwick International airport, small airfields and the Coastal area of Sussex.

Dave Padwick

Detective Inspector Dave Padwick has 22 years police service, working in the Met Police for the first 9 years and the rest of his career in Sussex. Dave Padwick has worked in a number of roles - response, community, Operations dept, ANPR and for the last 2 years DI Gatwick Ports Counter Terrorist Intelligence Unit. Obtained a Masters degree in Criminal Justice Studies completing academic research into Police partnership working and has played a pivotal role in developing a community engagement programme which includes enhanced community training and briefing for officers.
